CHAPTER _____

1 AN ACT concerning

2 **Vehicle Laws - Speed Monitoring Systems - Statewide Authorization and Use**
3 **in Highway Work Zones**

4 FOR the purpose of expanding to all counties and municipalities in the State the
5 authority to use certain speed monitoring systems to enforce certain highway
6 speed laws under certain standards and procedures; altering the speed of a
7 motor vehicle at which a speed monitoring system will produce a recorded
8 image of the vehicle; prohibiting the use of a speed monitoring system in a local
9 jurisdiction unless authorized by the governing body by ordinance or resolution
10 adopted after reasonable notice and a public hearing; requiring a county, before
11 using a speed monitoring system at certain locations, to obtain certain approval,
12 provide certain notice, and provide a municipal corporation instead of the
13 county the opportunity to use a speed monitoring system at the locations;
14 requiring certain local ordinances or resolutions to provide for the issuance of
15 warnings during a certain period for certain violations; ~~increasing the~~
16 ~~maximum speed limit for the purpose of establishing residential highways on~~
17 ~~which speed laws may be enforced using speed monitoring systems~~ limiting the
18 operation of a speed monitoring system in a school zone; requiring a local
19 jurisdiction to publish a certain notice before activating a certain speed
20 monitoring system; ~~requiring a certain speed monitoring system placed in a~~
21 ~~certain location to be calibrated only to record images of motor vehicles~~
22 ~~traveling at or above a certain speed~~; repealing a certain requirement that an
23 individual provide certain information to satisfy a certain evidentiary burden;
24 requiring the Chief Judge of the District Court to consult with certain agencies
25 in adopting certain procedures; clarifying that certain fines for certain motor

2 the number of citations issued or paid under this Act; requiring the issuance of
3 warnings for a certain time period for certain violations; defining certain terms;
4 repealing a certain definition; altering a certain definition; making certain
5 stylistic changes; making a technical correction; restricting the use of certain
6 revenues generated by this Act; ~~requiring a local jurisdiction to remit revenue~~
7 ~~generated from the use of speed monitoring systems to the Comptroller for~~
8 ~~deposit to the General Fund of the State if the revenue is not spent within a~~
9 ~~certain period of time providing for the distribution of certain revenues collected~~
10 by political subdivisions as a result of violations enforced by speed monitoring
11 systems; requiring a political subdivision to submit a certain report under
12 certain circumstances; providing for the application of this Act; providing that
13 existing obligations or contract rights may not be impaired by this Act;
14 providing that certain provisions of this Act do not apply to certain speed

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
9 MARYLAND, That the Laws of Maryland read as follows:

10 **Article – Courts and Judicial Proceedings**

11 7–302.

12 (e) (1) A citation issued pursuant to § 21–202.1 or § 21–809 of the
13 Transportation Article shall provide that the person receiving the citation may elect to
14 stand trial by notifying the issuing agency of the person’s intention to stand trial at
15 least 5 days prior to the date of payment as set forth in the citation. On receipt of the
16 notice to stand trial, the agency shall forward to the District Court having venue a
17 copy of the citation and a copy of the notice from the person who received the citation
18 indicating the person’s intention to stand trial. On receipt thereof, the District Court
19 shall schedule the case for trial and notify the defendant of the trial date under
20 procedures adopted by the Chief Judge of the District Court.

21 (2) A citation issued as the result of a traffic control signal monitoring
22 system or speed monitoring system controlled by a political subdivision shall provide
23 that, in an uncontested case, the penalty shall be paid directly to that political
24 subdivision. A citation issued as the result of a traffic control signal monitoring system
25 controlled by a State [agency or a speed monitoring system,] **AGENCY, OR AS A**
26 **RESULT OF A TRAFFIC CONTROL SIGNAL MONITORING SYSTEM OR A SPEED**
27 **MONITORING SYSTEM** in a case contested in District Court, shall provide that the
28 penalty shall be paid directly to the District Court.

29 (3) Civil penalties resulting from citations issued using traffic control
30 signal monitoring systems or speed monitoring systems that are collected by the
31 District Court shall be collected in accordance with subsection (a) of this section and
32 distributed in accordance with § 12–118 of the Transportation Article.

33 (4) (I) **FROM THE FINES COLLECTED BY A POLITICAL**
34 **SUBDIVISION AS A RESULT OF VIOLATIONS ENFORCED BY SPEED MONITORING**

22 (II) 1. FOR ANY FISCAL YEAR, IF THE BALANCE
23 REMAINING FROM THE FINES COLLECTED BY A POLITICAL SUBDIVISION AS A
24 RESULT OF VIOLATIONS ENFORCED BY SPEED MONITORING SYSTEMS, AFTER
25 THE COSTS OF IMPLEMENTING AND ADMINISTERING THE SYSTEMS ARE
26 RECOVERED IN ACCORDANCE WITH SUBPARAGRAPH (I)1 OF THIS PARAGRAPH,
27 IS GREATER THAN 10% OF THE TOTAL REVENUES OF THE POLITICAL
28 SUBDIVISION FOR THE FISCAL YEAR, THE POLITICAL SUBDIVISION SHALL REMIT
29 ANY FUNDS THAT EXCEED 10% OF THE TOTAL REVENUES TO THE
30 COMPTROLLER.

1 (o) (1) In this subsection, “recorded images” has the meaning stated in §
2 21–202.1 or § 21–809 of the Transportation Article.

3 (2) Except as provided in paragraph (3) of this subsection, a custodian
4 of recorded images produced by a traffic control signal monitoring system operated
5 under § 21–202.1 of the Transportation Article or a speed monitoring system operated
6 under § 21–809 of the Transportation Article shall deny inspection of the recorded
7 images.

8 (3) A custodian shall allow inspection of recorded images:

9 (i) as required in § 21–202.1 or § 21–809 of the Transportation
10 Article;

11 (ii) by any person issued a citation under § 21–202.1 or § 21–809
12 of the Transportation Article, or an attorney of record for the person; or

13 (iii) by an employee or agent of [a law enforcement] AN agency
14 in an investigation or proceeding relating to the imposition of or indemnification from
15 civil liability pursuant to § 21–202.1 or § 21–809 of the Transportation Article.

18 (a) (1) In this section the following words have the meanings indicated.

19 [(2) “Local police department” means:

20 (i) The Montgomery County Department of Police; and

21 (ii) The police department of any municipal corporation in
22 Montgomery County.]

23 (2) “AGENCY” MEANS:

24 (I) A LAW ENFORCEMENT AGENCY OF A LOCAL POLITICAL
25 SUBDIVISION THAT IS AUTHORIZED TO ISSUE A CITATION FOR A VIOLATION OF
26 THE MARYLAND VEHICLE LAW OR OF LOCAL TRAFFIC LAWS OR REGULATIONS;
27 OR

28 (II) FOR A MUNICIPAL CORPORATION THAT DOES NOT
29 MAINTAIN A POLICE FORCE, AN AGENCY ESTABLISHED OR DESIGNATED BY THE
30 MUNICIPAL CORPORATION TO IMPLEMENT THIS SUBTITLE USING SPEED
31 MONITORING SYSTEMS IN ACCORDANCE WITH THIS SECTION.

1 (3) (i) “Owner” means the registered owner of a motor vehicle or a
2 lessee of a motor vehicle under a lease of 6 months or more.

3 (ii) “Owner” does not include:

4 1. A motor vehicle rental or leasing company; or

5 2. A holder of a special registration plate issued under
6 Title 13, Subtitle 9, Part III of this article.

7 (4) “Recorded image” means an image recorded by a speed monitoring
8 system:

9 (i) On:

10 1. A photograph;

11 2. A microphotograph;

12 3. An electronic image;

13 4. Videotape; or

14 5. Any other medium; and

15 (ii) Showing:

16 1. The rear of a motor vehicle;

17 2. At least two time-stamped images of the motor
18 vehicle that include the same stationary object near the motor vehicle; and

19 3. On at least one image or portion of tape, a clear **AND**
20 **LEGIBLE** identification of the **ENTIRE** registration plate number of the motor vehicle.

21 (5) “Speed monitoring system” means a device with one or more motor
22 vehicle sensors producing recorded images of motor vehicles traveling at speeds at
23 least [10] **12** miles per hour above the posted speed limit.

24 (6) “Speed monitoring system operator” means [an individual who] **A**
25 **REPRESENTATIVE OF AN AGENCY OR CONTRACTOR THAT** operates a speed
26 monitoring system.

27 (b) (1) **(I) A SPEED MONITORING SYSTEM MAY NOT BE USED IN A**
28 **LOCAL JURISDICTION UNDER THIS SECTION UNLESS ITS USE IS AUTHORIZED BY**
29 **THE GOVERNING BODY OF THE LOCAL JURISDICTION BY LOCAL LAW ENACTED**
30 **AFTER REASONABLE NOTICE AND A PUBLIC HEARING.**

1 **(II) BEFORE A COUNTY MAY USE A SPEED MONITORING**
 2 **SYSTEM ON A STATE HIGHWAY AT A LOCATION WITHIN A MUNICIPAL**
 3 **CORPORATION, THE COUNTY SHALL:**

4 **1. OBTAIN THE APPROVAL OF THE STATE HIGHWAY**
 5 **ADMINISTRATION;**

6 **2. NOTIFY THE MUNICIPAL CORPORATION OF THE**
 7 **STATE HIGHWAY ADMINISTRATION'S APPROVAL OF THE USE OF A SPEED**
 8 **MONITORING SYSTEM AT THAT LOCATION; AND**

9 **3. GRANT THE MUNICIPAL CORPORATION 60 DAYS**
 10 **FROM THE DATE OF THE COUNTY'S NOTICE TO THE MUNICIPAL CORPORATION**
 11 **TO ENACT AN ORDINANCE AUTHORIZING THE MUNICIPAL CORPORATION**
 12 **INSTEAD OF THE COUNTY TO USE A SPEED MONITORING SYSTEM AT THAT**
 13 **LOCATION.**

14 **(III) AN ORDINANCE OR RESOLUTION ADOPTED BY THE**
 15 **GOVERNING BODY OF A LOCAL JURISDICTION UNDER THIS PARAGRAPH SHALL**
 16 **PROVIDE THAT FOR A PERIOD OF AT LEAST 30 DAYS AFTER THE FIRST SPEED**
 17 **MONITORING SYSTEM IS PLACED IN THE LOCAL JURISDICTION, A VIOLATION**
 18 **RECORDED BY ANY SPEED MONITORING SYSTEM IN THE LOCAL JURISDICTION**
 19 **MAY BE ENFORCED ONLY BY THE ISSUANCE OF A WARNING.**

20 [(1)] **(IV) This section applies to a violation of this subtitle [that**
 21 **occurs in Montgomery County] recorded by a speed monitoring system that meets the**
 22 **requirements of this subsection and has been placed:**

23 [(i)] **1. ~~On~~ IN MONTGOMERY COUNTY, ON a highway in a**
 24 **residential [district] ~~DISTRICT~~, as defined in § 21-101 of this [title:**

25 1. **With] TITLE, WITH a maximum posted speed limit of**
 26 **[35] ~~45~~ miles per [hour; and**

27 2. **That has a speed limit that] HOUR, WHICH SPEED**
 28 **LIMIT was established using generally accepted traffic engineering practices; or**

29 [(ii)] **2. In a school zone established under § 21-803.1 of this**
 30 **subtitle.**

31 **(V) BEFORE ACTIVATING AN UNMANNED STATIONARY**
 32 **SPEED MONITORING SYSTEM, THE LOCAL JURISDICTION SHALL:**

1 **1. PUBLISH NOTICE OF THE LOCATION OF THE**
2 **SPEED MONITORING SYSTEM ON ITS WEBSITE AND IN A NEWSPAPER OF**
3 **GENERAL CIRCULATION IN THE JURISDICTION; AND**

4 **2. ENSURE THAT EACH SIGN THAT DESIGNATES A**
5 **SCHOOL ZONE INDICATES THAT SPEED MONITORING SYSTEMS ARE IN USE IN**
6 **SCHOOL ZONES.**

7 **(VI) A SPEED MONITORING SYSTEM IN A SCHOOL ZONE MAY**
8 **OPERATE ONLY MONDAY THROUGH FRIDAY BETWEEN 6:00 A.M. AND 8:00 P.M.**

9 (2) (i) A speed monitoring system operator shall complete training
10 by a manufacturer of speed monitoring systems in the procedures for setting up and
11 operating the speed monitoring system.

12 (ii) The manufacturer shall issue a signed certificate to the
13 speed monitoring system operator [upon] **ON** completion of the training.

14 (iii) The certificate of training shall be admitted as evidence in
15 any court proceeding for a violation of this section.

16 (3) A speed monitoring system operator shall fill out and sign a daily
17 set-up log for a speed monitoring system that:

18 (i) States that the speed monitoring system operator
19 successfully performed the manufacturer-specified self-test of the speed monitoring
20 system prior to producing a recorded image;

21 (ii) Shall be kept on file; and

22 (iii) Shall be admitted as evidence in any court proceeding for a
23 violation of this section.

24 (4) (i) A speed monitoring system shall undergo an annual
25 calibration check performed by an independent calibration laboratory.

26 (ii) The independent calibration laboratory shall issue a signed
27 certificate of calibration after the annual calibration check[, which] **THAT:**

28 1. Shall be kept on file; and

29 2. Shall be admitted as evidence in any court proceeding
30 for a violation of this section.

7 (c) (1) Unless the driver of the motor vehicle received a citation from a
8 police officer at the time of the violation, the owner or, in accordance with subsection
9 (f)(4) of this section, the driver of a motor vehicle is subject to a civil penalty if the
10 motor vehicle is recorded by a speed monitoring system while being operated in
11 violation of this subtitle.

12 (2) A civil penalty under this subsection may not exceed \$40.

13 (3) For purposes of this section, the District Court shall prescribe:

14 (i) A uniform citation form consistent with subsection (d)(1) of
15 this section and § 7-302 of the Courts Article; and

16 (ii) A civil penalty, which shall be indicated on the citation, to be
17 paid by persons who choose to prepay the civil penalty without appearing in District
18 Court.

19 (d) (1) Subject to the provisions of paragraphs (2) through (4) of this
20 subsection, [the local police department] **AN AGENCY** shall mail to [the owner,] **AN**
21 **OWNER** liable under subsection (c) of this section[,] a citation that shall include:

22 (i) The name and address of the registered owner of the vehicle;

23 (ii) The registration number of the motor vehicle involved in the
24 violation;

25 (iii) The violation charged;

26 (iv) The location where the violation occurred;

27 (v) The date and time of the violation;

28 (vi) A copy of the recorded image;

29 (vii) The amount of the civil penalty imposed and the date by
30 which the civil penalty should be paid;

31 (viii) A signed statement by a duly authorized [agent of the local
32 police department] **LAW ENFORCEMENT OFFICER EMPLOYED BY OR UNDER**

1 **CONTRACT WITH AN AGENCY** that, based on inspection of recorded images, the motor
2 vehicle was being operated in violation of this subtitle;

3 (ix) A statement that recorded images are evidence of a violation
4 of this subtitle;

5 (x) Information advising the person alleged to be liable under
6 this section of the manner and time in which liability as alleged in the citation may be
7 contested in the District Court; and

8 (xi) Information advising the person alleged to be liable under
9 this section that failure to pay the civil penalty or to contest liability in a timely
10 manner:

11 1. Is an admission of liability;

12 2. May result in the refusal by the Administration to
13 register the motor vehicle; and

14 3. May result in the suspension of the motor vehicle
15 registration.

16 (2) [The local police department] **AN AGENCY** may mail a warning
17 notice instead of a citation to the owner liable under subsection (c) of this section.

18 (3) Except as provided in subsection (f)(4) of this section, [the local
19 police department] **AN AGENCY** may not mail a citation to a person who is not an
20 owner.

21 (4) Except as provided in subsection (f)(4) of this section, a citation
22 issued under this section shall be mailed no later than 2 weeks after the alleged
