## **Contributory factors for reported child pedestrian casualties**

The tables on the following pages show the contributory factors for reported child pedestrian casualties (0–15 years old) in road incidents in Great Britain in 2009. These are the key actions and failures that in the opinion of the reporting police officer led directly to the incident. It includes only incidents where a police officer attended the scene and reported at least one contributory factor.

When a road incident is attended by a police officer, the contributory factors are usually recorded.

The first table summarises the main contributory factors that were recorded in 2009 that were attributed to child pedestrians (rather than drivers, for instance).

The second table summarises the main contributory factors that were recorded in 2009 that were attributed to drivers.

The figures in both tables add up to more than 100% because up to six contributory factors can be reported for each incident. For each of the casualties there may be more than one factor assigned to them, and there may also be other contributory factors (whether recorded or not) that are attributable to other vehicles or pedestrians involved in the incident – just because a contributory factor is assigned to a child pedestrian or driver does not mean that there were no other contributory factors. There are more vehicles involved than the total number of pedestrian casualties because some incidents involved more than one vehicle.
