The court having read the papers and heard the arguments rules as follows:

The motion is GRANTED. The court finds that Plaintiff executed a valid and binding forum selection clause agreeing that any action arising out of his employment would be brought or maintained exclusively in the Arizona State or Federal Courts. Plaintiff has failed to meet his heavy burden of showing that the forum selection clause is unreasonable, or that he did not freely and voluntarily enter into the agreement. Plaintiff is therefore required to resolve his employment dispute in Arizona. Accordingly, this action is dismissed.

Defendants' request for judicial notice is GRANTED.


